This is a Contract between The Kennels of Stone Creek and the pet owner whose signature appears below (hereinafter called "Owner").

1. Owner agrees to pay the daily board of \$30.00 per day per dog. Or the current daily charge in effect at time of boarding.
2. Owner further agrees to pay all costs and charges for special services requested, and all veterinary costs for the pet during the stay the pet is in the care of The Kennels of Stone Creek.
3. Owner further agrees that the pet shall not leave the kennel until all charges are paid to kennel by Owner.
4. By signing this Contract and leaving his pet with The Kennels of Stone Creek, Owner certifies to the accuracy of all information given about pet.
5. The Kennels of Stone Creek shall exercise reasonable care for the pet delivered by the Owner to kennel for boarding. Owner and The Kennels of Stone Creek expressly agree that The Kennels of Stone Creek's liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$500.00 per animal boarded. The Owner further agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of The Kennels of Stone Creek.
6. Owner specifically represents to Kennel that the pet has not been exposed to rabies or distemper within a thirty-day period prior to boarding.
7. All Charges incurred by Owner shall be payable upon pick-up of pet, or when billed by The Kennels of Stone Creek at address listed on contract. The Kennel shall have, and is hereby granted, a lien on the pet for any and all unpaid charges resulting from boarding pet at The Kennels of Stone Creek. The Owner hereby agrees that in the event the boarding charges are not paid when due in accordance with this contract, the Kennels of Stone Creek may exercise its lien rights upon ten days written notice given by The Kennels of Stone Creek to Owner by certified mail to address shown on contract.
8. If pet, becomes ill or if the state of the animal's health otherwise requires professional attention, The Kennels of Stone Creek, in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the animal, and the expenses thereof shall be paid by the Owner.
9. This Contract contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and The Kennels of Stone Creek.
